**ORDER:**

In the G.O. 1<sup>st</sup> read above, orders were issued recommending on fire protection and fire safety measures required to be taken in the existing buildings.

2. In the G.O. 2<sup>nd</sup> read above, Government have notified the A.P Regulation and Penalization of Buildings Constructed Unauthorisedly and in Deviation of the Sanctioned Plan Rules, 2015.

3. In the G.O. 3<sup>rd</sup> read above, the Director of Town and Country Planning, Andhra Pradesh, Hyderabad has requested the Government, to extend the guidelines issued in the G.O. 1<sup>st</sup> read above, to the AP BPS Rules, 2015 issued in the G.O. 2<sup>nd</sup> read above for the buildings constructed after 2007 pertaining to issue of Fire NOC as per the Andhra Pradesh Fire Act, 1999, so as to take further action for approval of buildings eligible under B.P.S, 2015 by the respective Urban Local Bodies.

4. Government, after careful examination of the matter, hereby decide to extend the recommendations of the High Empower Committee issued in the G.O. 1<sup>st</sup> read above, to the Andhra Pradesh BPS Rules, 2015 issued in the G.O.2<sup>nd</sup> read above, for the buildings constructed after 2007 pertaining to issue of Fire NOC as per the A.P. Fire Act, 1999, so as to take further action for approval of buildings eligible under B.P.S - 2015 in Urban Local Bodies in the State of Andhra Pradesh.

5. The Director of Municipal Administration, Andhra Pradesh, Hyderabad, the Commissioner, Andhra Pradesh Capital Region Development Authority, Vijayawada, the Director of Town & Country Planning, A.P., Hyderabad, the Vice Chairman, Visakhapatnam Urban Development Authority/ Tirupathi Urban Development Authority / Puttaparthi Urban Development Authority, the Director General, AP State Disaster Response & Fire Services, Hyderabad and the Managing Director, APTRANSCO, Hyderabad shall take action, accordingly.
